








Use only provided AC/DC adapter model W&T-AD36W052300F manufactured by W&T Electronics Co., Ltd., with output rating 5.2VDC @ 3A, or model CDS015-T051, manufactured by Adapter Technology Co., Ltd., with output rating 5.15VDC @ 3A.

INSTALLATION

Plug the provided power supply into the barrel connector on the bottom of the PIN Pad and plug the Power Supply's power cable into the nearest outlet. Use an outlet installed near the equipment that is easily accessible.





Main Plug of the adapter acts as disconnect device, the socket-outlet shall be installed near the equipment and shall be easily accessible.


Warning: The Adapter used must be marked with "LPS" or "Limited Power Sources"; any others are prohibited for use.



2 Connect a Cat 5e (or better) Ethernet cable with Internet connection to the RJ-45 connector on the side of the PIN Pad.



If wall mounting, install two wood or drywall screws 5 inches apart into the wall 1m to 1.5m from the floor and per local zoning, safety, and ADA regulations. Use wall anchors if installing into drywall between studs. Hang the PIN Pad on the screw heads using the slots (circled below) in the back of the PIN Pad.

Alternately, the PIN Pad can be installed on a standard 75mm VESA mount (noted in blue).





After the PIN Pad boots, call the MTI Technical support number shown on the PIN Pad's display. The Support Technician will ask for your STORE NAME and for the PIN Pad serial number shown on the initial screen.



Once the PIN Pad is associated with your Store, the PIN Pad will display the time of day as set in the MTI Connect™ cloud.



To activate a key, tap it on the RFID symbol and enter your PIN. If successful, a confirmation screen will appear.



To deactivate an active key, tap it on the RFID symbol and touch CONFIRM to deactivate.






1 Touch anywhere on the left side of the screen to open the service menu.



2 Touch the top "Display" icon and then touch Rotate option to rotate the screen 180° for wall mounting.
